Counselling Registration Fee (Non-Refundable):

The prescribed registration fee of Rs. 500/- (for Karnataka SC/ST/Cat-1/PWD candidates), Rs. 1000/- (for Karnataka General/2A/2B/3A/3B candidates), Rs. 2000/- for Non-Karnataka candidates, and Rs. 5,000/- (for NRI Ward/NRI/OCI/PIO/Foreign Nationals candidates) should be remitted through payment gateway provided using a Credit Card or a Debit Card issued by banks in India or through Internet banking or by downloading bank challan.

- (v) Residential Certificate (if applicable)
- (vi) Caste Certificate (if applicable)
- (vii) Passport Size Photo (Scan Copy)
- (viii) Signature specimen (Scan Copy)

Documents required for NRI Seats:

- i) The final print out of the Online Registration Form.
- ii) Original Copy of the Challan for having paid the fees.
- iii) 'UG NEET' Admission Ticket and UGNEET- Score Card
- iv) Any valid Identity Card (Driving License / Voter ID / Passport / PAN / Aadhar Card)
- v) SSLC / 10th Standard Marks Card
- vi) 2nd PUC / 12th Standard Marks Card
- vii) 2nd PU /12th standard Study Certificate issued by concerned college with seal signature of Principal
- viii) TWO recent passport size photographs
- ix) Candidate's parents resident certificate issued by the Embassy of that country complying with the Income Tax Rules / any other certificates to establish evidence that they are resident of that country / affidavit on Rs.100/- e-stamp paper to that effect.
- x) Candidate's passport / VISA / Resident VISA.
- xi) Citizenship of the candidate.
- xii) Income Tax Documents required as per the Income Tax Act 1961.
- xiii) Candidate's study certificate for having studied outside India where applicable for the qualifying examination.

OTHERS Quota Seats: Open to all UGNEET qualified candidates except NRI / PIO / OCI and Foreign National.
